The valuation information required by 211.34 d , MCL, is the same information needed for P.A. 5 of 1982, Section 211.24 e , MCL "Truth in Taxation". A different formula is used for Section 24 e than is used for Section 34d, but the 2018 Taxable Value, 2019 Taxable Value, Taxable Value of Losses, and Taxable Value of Additions are the same quantities used in both formulas.
This form is to be filed with the State Tax Commission and with each unit of local government which has taxable property located in more than one county.
