

NOTICE FROM HILLSDALE COUNTY COMMISSIONER CHAIRMAN MARK WILEY AND CHIEF JUDGE SARA LISZNYAI REGARDING THE COUNTY AND COURT RESPONSE TO COVID-19

EFFECTIVE WEDNESDAY, MARCH 18, 2020 AND UNTIL FURTHER NOTICE:

ALL COUNTY BUILDINGS WILL BE CLOSED TO THE PUBLIC EXCEPT FOR EMERGENCY MATTERS. THIS INCLUDES THE COURTHOUSE, THE COURTHOUSE ANNEX, THE FRIEND OF THE COURT, THE COUNTY OFFICE BUILDING AND THE MSU EXTENSION OFFICE.

ALL COURTROOMS ARE CLOSED TO THE PUBLIC AND ONLY EMERGENCY HEARINGS WILL TAKE PLACE.
