

DESCRIPTION OF LAND PLATTED

The land embraced in the annexed plat of "Lake Diane - No. 1" Being a Subdivision of Part of the NW. fractional 1/4, Sec. 3, T. 9 S., R. 3 W., Amboy Twp., Hillsdale County, Michigan being a replat of Outlot "A" of "Lake Diane" as recorded in Liber 7 of plats pages 39 thru 42, Hillsdale County records, comprises 21 lots numbered 146 thru 166 and a Park and is described as follows:

Commencing at the Northwest corner of Sec. 3, T. 9 S., R. 3 W., thence East a distance of 1797.98 feet, thence South a distance of 865.80 feet to the point of beginning, being the Northwest corner of said Outlot "A" of "Lake Diane";

Thence S. 86° 56' 25" E. a distance of 291.12 feet to a point of curvature;

Thence Southeasterly along the arc of a curve, radius of 90.00 feet, central angle of 91° 51° 05", long chord bearing S. 41° 00° 53" E., long chord length of 129.32 feet, a

distance of 144.28 feet to a point of tangency; Thence S. 4° 54' 40" W. a distance of 393.40 feet;

Thence S. 30° 14' 45" W. a distance of 229.67 feet;

Thence S. 46° 21' 55" W. a distance of 244.52 feet to the beginning of a meander line along

the shore of Lake Diane; Thence N. 28° 56' 30" W. a distance of 111.46 feet; Thence N. 28° 35' 30" W. a distance of 200.88 feet;

Thence N. 23° 17' 00" E. a distance of 127.88 feet;

Thence N. 72° 44° 25" W. a distance of 130.11 feet to the termination of the meander line along the shore of Lake Diane;

Thence N. 3° 08' 55" E. a distance of 169.99 feet;

Thence N. 31° 13' 41" E. a distance of 318.66 feet to the point of beginning.

SURVEYOR'S CERTIFICATE

I hereby certify that the plat hereon delineated is a correct one and that permanent metal monuments consisting of bars not less than one-half inch in diameter and 36 inches in length, or shorter bars of not less than one-half inch in diameter lapped over each other at least 6 inches with an over-all length of not less than 36 inches, encased in a concrete cylinder at least 4 inches in diameter and 36 inches in depth, have been placed at points marked thus (0) as thereon shown at all angles in the boundaries of the land platted, at all the intersections of streets, and at the intersections of streets with the boundaries of the plat as shown on said plat.
